Wayne and Georgia Gamm

Wayne Gamm grew up in rural Bowling Green, MO in what is known as the Vera community. Wayne and his wife Georgia were married in 1960. They are the parents of four children; three daughters and one son. Marilyn, a minister in a Presbyterian Church in Madison, WI, is married to Craig Howard who is a minister working at McCormick Seminary. Jo Ann lives in Kandiyohi, MN and has two daughters ages 14 and 11. She works at a hospital complex. Larry is married to Carmen and has a son 1 ½. They live near Bowling Green. Larry worked for NRCS for about 10 yrs then worked for a John Deere dealer, Jennings Imp.& Dave White Imp., for four years as a sales manager. He currently works as a loan officer for US Bank in Bowling Green. Carmen works for Community State Bank as a computer technician. Carol is married to James Smith and lives in Holt Summit, MO. He has served on the Pike County Extension Council at two different times; serving as a vice chairman, a chairman and as a treasurer. He served on the ASC committee for 20 years. Both Wayne and Georgia are members of the Providence Concord Presbyterian Church in Vera, where Wayne serves as an elder and a song leader. Georgia is a past Sunday School teacher and a deacon. They are members of the Pike County Historical Society of which Wayne is a past president.

Georgia is a member of the Bowling Green Chapter of Daughter of the American Revolution. Her most recent office was as Regent of her chapter.
